1. Construction Documents shall be drawn upon suitable material. Construction Documents shall be of sufficient clarity to indicate the location, nature, and extent of the work proposed and show in detail that it will conform to the provisions of the State Construction Code and relevant laws, ordinances, and rules and regulations, as determined by the Building Official.
2. **Section 23a of the State of Construction Code Act of 1972, PA 230, MCL 125.1523a**, prohibits a person from conspiring to circumvent the licensing requirements of this State relating to persons who are to perform work on a residential building or a residential structure. Violators are subject to civil fines.
3. A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid unless the work authorized by such permit is commenced within 180 days after its issuance, or if the work authorized by such permit is suspended or abandoned for a period of 180 days after the time the work is commenced. **A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN 180 DAYS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED.**
